



A government that violates the supreme constitutional law of the nation it is sworn to uphold commits a declaration of war against the people and the crime of treason when they knowingly and intentionally do so.

When they interfered in our judiciary process with the SNC LAVALIN SCANDALS ,  
Stole money from the public via we charity.

It was a declaration of war.

When they told us that we had to "declare our personal vaccine status" , and that we had to present proof to them that we've been "fully vaxxed" or they take away our job,  
*that was a declaration of war.*

When they told us they could deny us medical treatment if we didn't roll up our sleeves and participate in bio experimentations they contracted to against our best interests and without our knowledge or consent ,

*that was a declaration of war.*

When they told us they had the right to shut down our small businesses because it was no longer deemed "essential," *while every business and job is essential to every individual's health*  
*that was a declaration of war.*

When they told us that we couldn't go to church to worship God,  
*that was a declaration of war.*

When they told us that we couldn't board a plane or a subway, or enter a restaurant unless complied with their dictates ,  
*that was a declaration of war.*

When the Prime Minister illegally invoked the Emergency act to silence the majority of Canadians who are speaking out and demanding change of the de facto government,  
*this was a declaration of war.*

When in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of

the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men and women are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and Labour.--That to secure these rights, Governments are instituted among men and women, deriving their just powers from the consent of the governed, --that whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to establish a Constitution to institute a new de jure Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness.

Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly, all experience hath shown, that mankind is more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.

Therefore ;

We the people of the country known as Canada hereby put forth the following DECLARATION OF EMERGENCY for the Violations to our constitution under Section 52(1) reaffirms constitutional supremacy. It imposes an obligation on bodies empowered to determine questions of law to do so in a manner consistent with the Constitution and to invalidate or treat as invalid a law to the extent of its inconsistency with the Constitution

We the people by our own authority, demand the immediate actions of our law enforcement institutions and existing judiciaries to uphold their duties and requirements under public contract to immediately suspend and criminally charge a specific list of parliamentarians and their identified accomplices in the evidence WE THE PEOPLE have been presenting to INACTION for nearly two years .

It is our sovereign authority as the conductor of and authority over the equity within our society to enforce the supremacy of our laws over the DEFACTO abuse of the authority of legislation. We demand that all remaining staff within parliament who manage our affairs so professionally and in servitude continue to do so accordingly and regardless of those absent .

We the people demand an immediate audit and thorough investigation into all actions, expenditures, contracts and proposals of the Corporation of the Government of Canada and all its subsidiaries, to

supply a full report in full transparency to be made publicly available upon completion .  
To hold all treasonous acts or founded traitors accountable to the full extent of our laws .  
And to provide all necessary supports for our people to move forward peacefully and lawfully in constitutional conventions , in the pursuit of protection to our life, land , and liberty.

We the people declare the immediate enforcement of OUR CONSTITUTIONAL CANADIAN BILL OF RIGHTS to be applied as the supreme law over all jurisdiction in Canada during these times of conventions wherein;

It is hereby recognized and declared that in Canada the people are the supreme governing authority over their life, liberty, security and property, that individual liberties are a necessity to nature and the natural world and the interference or infringement on these unalienable divine natural rights would be a detriment to all life , it is understood that there have existed and shall continue to exist without discrimination by reason of race, national origin, colour, religion , sex or otherwise supreme and authoritative rights and freedoms by the divinity of each our individual peoples very existence is f which is clearly defined and contracted to by armed and organized states internationally for the purpose of peace with the developments that resulted from the Geneva conventions of 1864 and the creation of the INTERNATIONAL SECURITY COUNCIL who is charged to protect and come to the aid of independent and civil societies in the event that the universal code of human rights as described in the universal declaration of human rights is/has been violated.

We the people do **officially make this ;**  
**DECLARATION OF EMERGENCY:**

Canada is a nation composed of people who are internationally recognized as Peaceful Humanitarians that exemplify a path to evolution for all people by our ability to coexist in general harmony with considerable compassion for one another.

Recently Justin Trudeau declared a state of emergency and enacted the Emergency Act in a malicious attempt to further domestically terrorize Canadians, officers were militarized and acting as an occupational force , assaulting and violently arresting people for expressing their rights .

Legal scholars and public inquiries have since proven that this Act had not been invoked properly with the checks and balances demanded by the legislation.

Under this declaration of emergency we claim the right to exercise the rights, freedoms and powers that exist naturally and which are supreme without exception and invincible indefinitely.

Although these rights, freedoms and powers have always existed we the good and patient people of Canada have refrained from exercising them choosing instead to place our trust in the government bodies we entrusted to serve.

Therefore,

We the Free People of Canada do hereby publicly and internationally make the following

#### PROCLAMATION:

- We claim the right to revoke consent to be governed or represented by corrupt politicians and to establish a new system of government utilizing existing technology for discussing issues, determining actions, and building consensus.
- We claim the right to convene grand juries according to established and acceptable international standards by way of the ICC in full respect and ethical care to uphold the universal code of human rights of which is defined law in its clear , concise literal form.
- We claim the right to outsource support in the event where we cannot obtain accountability from criminal actions that have infested our society to bring those who engage , participate, construe, endorse, neglect or comply to international criminal court for war crimes , crimes against humanity and all other violations described within the Rome Statute .
- We claim the right to distinguish between geographical areas and legal entities with similar sounding names and to exist as human beings within the geographical areas without existing as persons with obligations and duties within the legal entities with similar sounding names.
- We claim the right to confront and condemn the malicious use of premeditated psycholinguistic manipulation tactics as a modern form of slavery and the most egregious act of trespass on individuals and collectives alike.
- We claim the right to make ethics violations a criminal offence.
- We claim that the territory of Canada belongs to the people of Canada and not to the Corporations called the federal government or provincial government of any place that mimics the various geographical titles of the land , and that our natural resources belong to the signatory , land owners amongst the various bands and clans of tribal peoples that have existed on this land since time immemorial and that we the people who have been so blessed

by them to consume and enjoy the privilege of the wealthiest land and resources in our world while they were subjected to the genocide, apartheid, murders and rapes that they have been forced to endure for centuries without our comprehension or awareness; make no discriminate distinctions that claim various levels of value could be applied to any life over another , that we the people will stand in their defence and come to their aid as all peoples have an obligation to live our lives according to the rules of the nature of things in the principles that define the future we want for our children.

- We claim the right to demand the accuser all remain suspended from positions of public authority until a full and complete forensic accounting of all expenditures, contracts , proposals , treaties , independent financial gains , secret meetings and hidden deals have been forensically investigated to examine ensure that the interests of the people who this public service corporation was created to serve have been competently managing and maintaining our interests in full honest and transparent integrity with respect to the obligations they are required to obey as clearly defined in the declaration of human rights, the rome statute, the international covenant on civil and political rights , and the Nuremberg code.
- That any and all funds associated with any and all accounts including but not limited to any accounts created through the issuance of government documentation that is presented as a requirement and suggests that our people will benefit from, with perks that they misleadingly assert we would otherwise not be entitled to be immediately revealed returned to the possession of each individual who owns them.
- We claim that the Free People of Canada are not bound by any agreements entered into by past governments as we are rejecting not only their claim to govern us and/or our country but we are rejecting all international agreements with any international bodies if said agreements are not to our benefit.
- We claim that the World Economic Forum is a criminal organization that is in control of the instruction of states that are actively committing crimes against humanity .
- We claim the right to amend the existing constitution to enforce our sovereign authority over the corporations and institutions that were created to serve and manage our interests , including but not limited to the complete abolishment of the royal styles and titles act , all political parties , the electoral voting process, parliamentary privilege and the abolition of any act of legislation that contradicts the supreme laws as defined in the CANADIAN BILL OF RIGHTS as well as the addition of parliamentary ethics violations to our

criminal code . That parliament shall continue to operate with all the committed administrative staff that are the true managers of our interests , operations and affairs regardless of those who are absent .

- We claim the right to abolish the INDIAN ACT as slavery is a crime in humanity and this unlawful act of legislation is responsible for the systemic abuses to all First Nations , native and tribal peoples , including but not limited to the continued apartheid, genocide, sterilization, kidnapping , oppression, racism, and extortion that still happens today.

WHEREAS : anyone who interferes with the aforementioned rights or the creation , transition , reconstruction and/or operation of the institutions herein mentioned is committing crimes against the Free People of Canada
